## 2023 Legislative Affairs Updates for the OCC Website for 1st Quarter

# The Major Richard Star Act

Congress fails to pass the Major Richard Star Act before the end of 2022. Senate Bill 344, which would amend title 10, United States Code, was introduced in the Senate (02/22/2021). This bill would allow a veteran with a combat-related disability and fewer than 20 years of creditable service. The Star Act did reach the significant 290-sponsor milestone to earn entry on the House consensus calendar in 2022, and will have to be reintroduced. Update: Act SB:344 was reintroduced into Congress on 02/09/2023. It has been read twice and referred to the Committee on Armed Services. To date, there has been no Senate vote and no House vote. When signed into law, the act would fix federal policy that prevented thousands of severely wounded combat veterans from receiving their earned retirements. This unjust policy states that if a veteran is separated from the service due to combat related injuries — before completing 20 credible years — the federal government will keep the veteran's earned retirement. allowing a veteran, with combat-related injuries and fewer than 20 credible years, to receive his or her earned retirement.

## Ohio HB126

USPHS and NOAA personnel have been excluded because the current definition in section 718.01 'Definitions' of the Revised Code, State of Ohio only refers to 'Armed Services'. Proposed House Bill 126 would change the language to be inclusive of the 'Uniformed Services'. See wording proposed change in HB126 below.

Staffers in Representative Adam Miller's office recommend we ask our members and others to contact their representatives asking them to support HB126, and additionally asking that they consider adding their name as a Cosponsor. A list of all the State representatives (House and Senate) with email addresses, and key personnel in each governing body is attached. We hope our Chapter members act to support their fellow service members.
